2. A Salzbur01 will send its decision within 4 weeks after the application deadline. G KRITIS01 will send its decision within 6 weeks after the application deadline.
3. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI. Each student can print the transcript of records personally.
4. *In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."*

### 1. Grading systems of the institutions

University of Crete grading system is characterized as follows:

EXCELLENT: from 8.50 to 10,

VERY GOOD: from 6.50 to 8.49,

GOOD: from 5 to 6.49,

Minimum passing grade is 5

Grade less than 5 in the individual courses indicates failure.

1	EXCELLENT: Outstanding performance
2	GOOD: Generally good, but with some errors
3	SATISFACTORY: Generally sound work with a number of substantial errors
4	SUFFICIENT: Performance meets the minimum criteria
successfully completed	Positive performance, where a strict differentiation is not adequate
5	UNSATISFACTORY: Substantial improvement necessary; requirement of further work
not completed	Negative performance, where a strict differentiation is not adequate
