- Trade Politics:** Novel insights on what affects individual level support for trade agreements: Independent of their economic status and their countries' political system, citizens strongly favor trade agreements including environmental and labor rights clauses
- Environmental Politics:** My current research focuses mainly on climate change and conflict and shows that it depends on the type of environmental changes, such as droughts versus tropical storms, whether someone becomes a migrant in the first place and whether then he or she faces conflict in his or her new location.
